University of National and World Economy (hereinafter referred to as "Controller", "the University" or "we") performs its activities in accordance with the Bulgarian Personal Data Protection Act and the EU Regulation 2016/679 of the European Parliament and the Council of 27 April 2016 on the protection of individuals in regard to the processing of personal data and on the free movement of such data. This document aims to inform you about all aspects of the collection and processing of your personal data by the University and the rights you have, in relation to that processing.

Legal grounds for collecting, processing and storing your personal data

Art. 1. The University collects and processes your personal data on the basis of Art. 6, para. 1, Regulation (EU) 2016/679 (GDPR), and specifically based on any of the following grounds:

- For compliance with a legal obligation that applies to the Controller;
- For the performance of a task of public interest and implementation of official powers granted to the Controller;
- Your explicit consent to the processing of certain categories of personal data;
- For fulfilling obligations of the Controller under a contract with you or for taking steps at the request of the data subject before concluding a contract;
- For the purposes of the legitimate interests of the Controller or a third party;
- For protection of the vital interests of the data subject or other natural person.
- (2) The University performs its activities in compliance with the requirements of the regulations and the application of the Bulgarian Law of High education decree, published in State Gazette No. 112 of December 1995 and with all subsequent additions and amendments to it, the Ordinance on State Requirements for Acquiring Higher Education by educational and qualification degrees, Resolutions of the Council of Ministers, as well as the internal Regulations of the University and decisions of the Academic Council.

Objectives and principles for the collection, processing and storage of your personal data

- **Art. 2.** The University collects and uses your personal data in the volume that is minimally necessary to achieve the relevant purpose.
- **Art. 3. (1)** In the course of collecting, processing and storing your personal data, the University adheres to the following Principles:
 - lawfulness, fairness and transparency;
 - proportionality with the processing purposes and data minimization;
 - accuracy and relevance of the data;
 - storage limitation in accordance with purpose achievement;
 - integrity and confidentiality of the processing and ensuring an adequate level of security of the personal data.

Art. 5. In course of processing and storage of personal data, the University can process and store personal data, including for the fulfillment of its obligations to state and municipal bodies.

What types of personal data does the University collect, process and store

Art. 6. (1) The University performs the following operations with the personal data provided by you:

1. "Rector's office"

The following personal data processing operations are performed in the Rector's Office:

- 1.1. Processing of internal and external correspondence, letters, reports, complaints, etc.
- The purpose of the processing of personal data for this operation is administration and processing of internal and external correspondence to the Rector's office by submitting the information to the register of incoming and outgoing mail in the registry office.
 - ➤ Personal data processed by the Rector's Office when processing internal and external correspondence, letters, reports, complaints, etc. name, father's name and surname or another name according to the Identity Card, Personal identification number (PIN) or Personal identification number of foreigner, address, district, phone number, faculty number, Position. It is possible to be required provision and processing of additional data, depending on the correspondence exchanged.
 - ✓ Basis for processing your personal data The University collects, stores and processes personal data in regard with the operation "Processing of internal and external correspondence, letters, reports, complaints, etc." of individuals for the purposes of the Controller's legitimate interest, according to Art. 6, paragraph 1, letter "e" of the Regulation (EU) 2016/679 (GDPR). The legitimate interest is administration and processing of the University's internal and external correspondence.
 - Conclusion of Data protection impact assessment of the operation: Based on the above impact assessment, the personal data protection officer considers that the operation "Processing of internal and external correspondence, letters, reports, complaints, etc." is acceptable for performance and provides sufficient guarantees for the protection of the rights and legal interests of data subjects in accordance with Regulation (EU) 2016/679 (GDPR).
- **1.2. Signing of legal documents and orders** The purpose of processing personal data in this operation is in reference with drafting and signing of legal documents by the Rector of the University, including contracts, agreements, orders, etc.
 - Personal data processed by the Rector's Office when signing legal documents and orders - The personal data collected is determined by the role of the legal document itself in the organization. In this regard, the personal data collected for each document and their storage terms are covered in the operations

in the individual Departments of the University, which prepare them for signature by the Rector.

- ✓ Basis for processing your personal data The basis for processing personal data in this operation depends on the type of legal document that is being signed, respectively when signing contracts and related documents, including orders on employment relationships, the basis for processing your personal data is the conclusion and performance or taking steps for conclusion of a contract art. 6, paragraph 1, letter "b" of the Regulation (EU) 2016/679 (GDPR). When signing orders, the basis for processing is related to the fulfillment of a legal obligation that applies to the University based on its academic autonomy Art. 6, paragraph 1, letter "c" of the Regulation (EU) 2016/679 (GDPR), as well as on the basis of Art. 6, paragraph 1, letter "e" Regulation (EU) 2016/679 (GDPR) processing is necessary for the performance of official rights granted to the Controller in regard with Art. 19 of the Law on Higher Education and the Regulations of the University.
 - Conclusion of Data protection impact assessment of the operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Signing legal documents and orders" is acceptable for performance and provides sufficient guarantees for the protection of the rights and legal interests of data subjects in accordance with Regulation (EU) 2016/679 (GDPR).
- **1.3. Preparation and processing of secondment orders** The purpose of personal data processing in this operation is administration of the process of preparation and processing of secondment orders.
 - Personal data processed by the Rector's Office when preparing and processing secondment orders – three names of the individual, position, identity card data, passport data.
 - ✓ Basis for processing your personal data The University collects, stores and processes personal data on the basis of Art. 6, para. 1, "b" of the GDPR the processing is necessary for the purposes of performing a contract to which the data subject is a party.
 - Conclusion of Data protection impact assessment of the operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Preparation and processing of posting orders" is acceptable for performance and provides sufficient guarantees for the protection of the rights and legal interests of data subjects in accordance with Regulation (EU) 2016/679 (GDPR).

2. Business Services Department

The Business Services Department performs the following operations with personal data:

- **2.1. Organization of transport of university employees and/or necessary goods** The purpose of the of personal data processing in this operation is to organize and perform the transport of university employees for a business trip, participation in an event in another town/area or the certification in a receipt-handover protocol for received goods.
 - > Personal data processed by the Business Services Department for the organization of transport of university employees and/or necessary goods for the University three names, position held.
 - ✓ Basis for processing your personal data The University collects, stores and processes personal data for the performance of a concluded employment contract on the basis of Art. 6, paragraph 1, letter "b" of the GDPR or express consent of event participants or guests for whom transportation is organized Art. 6, paragraph 1, letter "a" of the GDPR. The data on the persons who accept and hand over the transported goods are processed on the basis of the University's legitimate interest in proving the performance of the concluded contract Art. 6, paragraph 1, letter "f" Regulation (EU) 2016/679 (GDPR).
 - Conclusion of the impact assessment of the operation with personal data: Based on the above impact assessment, the personal data protection officer considers that the operation "Organization of transport of university employees and/or necessary goods" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of data subjects in accordance with Regulation (EU) 2016/679 (GDPR).
- **2.2. Organizing, ordering and receiving supplies -** The purpose of processing personal data in this operation is the organization and execution of supplies of goods and materials for the University.
 - ➤ Personal data processed by the "Business Services" Department during the administration of the process of organizing, ordering and receiving supplies at the University three names; uniform civil number in case of issuing an invoice by a natural person.
 - ✓ Basis for processing your personal data The University collects, stores and processes personal data on the basis of Art. 6, para. 1, letter "b" of the GDPR the processing is necessary for the performance of a contract to which the University is a party, as well as for the protection of the University's legitimate interest in proving performance under the contract in case of possible claims Art. 6, para. 1, b. Regulation (EU) 2016/679 (GDPR).
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal

Data Protection Officer considers that the operation "Organizing, ordering and receiving supplies" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the data subjects in accordance with Regulation (EU) 2016/679 (GDPR).

- **2.3.** Processing of incoming and outgoing documents in the Registry Office The purpose of processing personal data in this operation is to organize the sending of outgoing letters from the University and the receipt of incoming letters, maintaining a register and storing the documentation.
 - > Personal data processed by the "Business Services" Department when administering the process of organizing transport and carriage at the University three names of the individual, address;
 - ✓ Basis for processing your personal data The University collects, stores and processes personal data to protect the legitimate interest of the University on the ground of Art. 6, para. 1, letter "f" Regulation (EU) 2016/679 (GDPR).
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the personal data protection officer considers that the operation "Processing of incoming and outgoing documents in the Registry Office" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the data subjects in accordance with Regulation (EU) 2016/679 (GDPR).

3. Department "Material - technical base and investments"

- **3.1. Organization of vacations in rest stations at the university -** The purpose of personal data processing in this operation is to administer the application process and provide accommodation in the UNSS Training and Rehabilitation Center of employees of the University, members of their families or outsiders.
 - Personal data processed by the Department "Material technical base and investments", at organization of vacations in rest stations at the university three names, PIN, identity card data; address; official position and labour term of service at the University.
 - ✓ Basis for processing your personal data The University processes personal data for the performance of a contract to which the data subject is a party or for taking steps at the request of the data subject before signing of the contract Art. 6, para. 1, letter "b" of the GDPR.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the personal data protection officer considers that the operation "Organizing vacations at rest stations to the university" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the data subjects in accordance with GDPR requirements.

- **3.2.** Activities related to maintenance and repair of the building stock The purpose of processing personal data in this operation is to organize the maintenance and the repairment of the University's building stock.
 - > Personal data processed by the Department "Material technical base and investments", at performing activities related to maintenance and repair of the building stock: three names.
 - ✓ Basis for processing your personal data The University collects, stores and processes personal data for the purposes of fulfilling concluded contracts, including contracts for public procurement Art. 6, paragraph 1, letter "b" of the GDPR.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Activities related to the maintenance and repair of the building stock" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the data subjects in accordance with GDPR requirements.
- **3.3.** Implementation of video surveillance in all premises and buildings of the University, as well as in the space around them The purpose of processing personal data in this operation is to ensure the safety of students, workers/employees, as well as all visitors in the University. An additional purpose of the operation is to control the performance of the work duties of all employees and university professors, as well as the establishment of committed violations and the imposition of disciplinary fines.
 - ➤ Personal data processed by the "Material Technical Base and Investments" Department when implementing video surveillance in all premises and buildings of the University, as well as in the space around them image data of the natural person.
 - ✓ Basis for processing your personal data The University collects, stores and processes personal data on the basis of Art. 6, paragraph 1, b. "f" of the GDPR to protect the legitimate interests of the Controller and on the basis of Art. 6, paragraph 1, b. "d" GDPR processing is necessary to protect the vital interests of the data subject or another natural person. The legitimate interest in the current operation is the implementation of security on the territory of the University and protection of life and health of students, university professors, employees, visitors, etc.;
 - Conclusion of the impact assessment of the personal data operation: Based on the above-mentioned impact assessment, the personal data protection officer considers that the operation "Performing video surveillance in all premises and buildings of the University, as well as in the space around them" is acceptable for performance and provides sufficient guarantees for the protection of rights and the legal interests of data subjects in accordance with GDPR requirements.

4. Human Resources Department

The following personal data processing operations are performed in the Human Resources Department:

- **4.1.** Conclusion and execution of labor contracts The purpose of personal data processing in this operation covers the selection process of employees, conclusion of the relevant contract and its administration and execution by the university, processing of accounting, tax and insurance information in accordance with the current legislation, actions for termination of the labor contract, proceeding the employee's responsibility according to the Labor Code.
 - ➤ Personal data processed by the Human Resources Department upon conclusion and execution of labor contracts three names of natural persons; personal identification number; Date and place of birth; permanent and current address; identity card data and passport data; criminal record data; data regarding individuals health condition; education degree; phone number; email; qualification and work experience; bank account data; family status data; data on the position held; data on foreign citizens; information about taught subjects.
 - ✓ Basis for processing your personal data Human Resources Department collects, stores and processes personal data in regard with the operation and the conclusion of labor contracts, the university processes personal data for the performance of a contract to which the data subject is a party or for taking steps at the request of the data subject before the conclusion of the contract art. 6, para. 1, letter "b" of the GDPR.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Conclusion and execution of an employment contract" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the data subjects in accordance with the requirements of the GDPR.

5. Legal Service and Public Procurement Department

The following personal data processing operations are performed in the "Legal Service and Public Procurement" Department:

- **5.1.** Conclusion and performance of contracts, including civil contracts and public procurement contracts The purpose of personal data processing is to identify the individual, the legal representative of the supplier for the purposes of concluding a public procurement contract and service contract and collecting the statutory documents according to the Bulgarian Law on Public orders.
 - ➤ Personal data processed by "Legal service and public procurement" when concluding and executing contracts, including civil contracts and public procurement contracts three names of natural persons or legal representative of a company; identification number; address; identity card data number, date of issuance, issuing authority, expiration date; contact phone number; bank account details.

- ✓ Basis for processing your personal data The Legal Service and Public Procurement Department collects, stores and processes personal data when organizing and conducting postgraduate qualifications on the basis of Art. 6, para. 1, letter "c" of the GDPR the processing is necessary for the purposes of complying with a legal obligation of the controller.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Conclusion and performance of contracts, including civil contracts and public procurement contracts" is acceptable for performance and provides sufficient guarantees for the protection of rights and legal interests of data subjects in accordance with GDPR requirements.
- **5.2. Initiation of proceedings and processing information about cases -** The purpose of the processing of personal data in this operation is the raising of legal claims of the University against third parties in court, defending against such claims brought against the University in court by third parties, implementing effective judicial decisions in the University's favour and preparation of diaries for keeping and reporting court cases.
 - ➤ Personal data processed by the Legal Service and Public Procurement Department when initiation of proceedings and processing information about cases three names of natural persons; identification number; address; correspondance address; email address; phone number; bank account details; health data; family status data.
 - Basis for processing your personal data The Legal Service and Public Procurement Department collects, stores and processes personal data when organizing and conducting postgraduate qualifications on the basis of Art. 6, para. 1, letter "c" of the GDPR the processing is necessary for the purposes of complying with a legal obligation of the Controller.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Initiation of proceedings and processing information about cases" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of data subjects in accordance with GDPR requirements.

6. Department "Educational Activity"

The following personal data processing operations are performed in the "Educational Activity" Department:

6.1. Operation "Organization and conduction of candidate student campaigns" - The purpose of the operation is the acceptance of an application for participation in a candidate student exam from students, the identification of the person when conducting exams (including identification and authentication of the candidate for student when conducting an online admission exam) and performing a ranking of the person's exam results.

The University perform the following operations which include processing of personal data within the framework of this operation:

- 1. Accepting a paper application from the candidate for student;
- 2. Creating the user profile in the system about each individual for the purposes of identifying everyone as a candidate student in the system and during an exam;
- 3. Administration of the examination hall allocation process for the purpose of allocating students to the various examination halls;
- 4. Identification of the candidate student during the examination/identification and authentication of the candidate student before and during the online entrance;
- 5. Preparation for the ranking of the results of the conducted personal examinations for the purpose of assessing whether the results are sufficient for admission to the desired specialties at the University.
- ➤ Personal data processed by the "Educational Activities" Department when organizing and conducting candidate-student campaigns three names of the natural persons; identification number; address; ID card data number, date of issuance, expiration date, issuing authority, citizenship; data for the health condition; family status data; data about education; gender; faculty number; personal number of a foreigner; average grades data; contact phone number; citizenship and residence status. During an online candidate-student entrance exam, in addition to the above data: the personal number of the candidate-student campaign; identity card data; photo image; video image; audio recording data; a six-digit code for future identification of the candidate which is also used when digitally signing documents related to the conduction of the exam; answers of the additional questions authenticating the candidate for student.
 - ✓ Basis for processing your personal data The above personal data is processed by the University on the basis of Art. 6, para. 1, b. "c" of the GDPR the processing is necessary to comply with a legal obligation that applies to the Controller, as well as on the basis of Art. 6, para. 1, b "e", of the GDPR Regulation, namely when exercising official powers granted to the Controller. Data on persons with disabilities are collected on the basis of Art. 6, para. 1, b. "a" in relation to Art. 9, para. 2, b. "a" of the GDPR express consent of the data subject for processing the data for one or more purposes.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the

operation "Organizing and conducting candidate student campaigns" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of data subjects in accordance with the requirements of the GDPR.

6.2. Enrollment of new students - The purpose of the processing of personal data in the present operation is the enrollment of newly admitted students in the University's specialties and the creation of an electronic student's record book.

The University performs the following operations of processing of personal data within the framework of this operation:

- 1. Registration of new students at the University;
- 2. Creating an electronic student's record book.
- ➤ Personal data processed by the "Educational Activities" Department when enrolling new students Student Enrollment Application; photo to create an electronic student's record book.
 - ✓ Basis for processing your personal data The above personal data is processed by the University on the basis of Art. 6, para. 1, letter "c" of the GDPR the processing is necessary to comply with a legal obligation that applies to the Controller, as well as on the basis of Art. 6, para. 1, letter "e", of the GDPR Regulation, namely when exercising official powers granted to the Controller. Data on persons with disabilities are collected on the basis of Art. 6, para. 1, letter "a" in relation to Art. 9, para. 2, letter "a" of the GDPR express assent of the data subject to their processing for one or more purposes.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Data Protection Officer considers that the operation "Enrollment of new students" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of data subjects in accordance with the requirements of the GDPR.

6.3. Administration of the study process, examination grades and ranking for scholarships

- The purpose of personal data processing in this operation is to serve the educational process (including online learning) at the University, including conducting exams (including online exams), compiling exam reports, ranking for scholarships and dormitories.

- 1. Administration of the learning process;
- 2. Conducting exams (including online exams);
- 3. Completing a General Book with information about the educational process of each student;
- 4. Student Scholarship Ranking.

- Personal data processed by the Academic Activities Department when administering the study process, exam grades and scholarship ranking During the implementation of the operation, the Department collects data on student evaluations and changes to the data already provided by the students when enrolling, including marital status.
 - ✓ Basis for processing your personal data The above personal data are processed by the University on the basis of Art. 6, para. 1, letter "c" of the GDPR the processing is necessary to comply with a legal obligation that applies to the Controller, as well as on the basis of Art. 6, para. 1, letter "e", of the GDPR Regulation, namely when exercising official powers granted to the Controller. Data on individuals with disabilities is collected on the basis of Art. 6, para. 1, letter "a" in relation to Art. 9, para. 2, b. "a" of the GDPR express consent of the data subject to their processing for one or more purposes.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Administration of the study process, examination grades and ranking for scholarships" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the subjects of the data in accordance with the requirements of the GDPR.
- **6.4. Graduation of students -** The purpose of personal data processing in this operation is to serve the graduation process of students and the issuance of the relevant documents in this regard.

- 1. Initiating the graduation procedure;
- 2. Change of student status graduate;
- 3. Issuance of a diploma for the concluded education.
- Personal data processed by the "Educational Activity" Department when performing the operation Graduation of students When performing the operation, the Department collects the information entirely from the "Student" system about the results of exams and about the minimum exams that are necessary for graduation. In the current operation, no new personal data about the persons is collected, apart from those already provided in the "Student" system.
 - ✓ Basis for processing your personal data The above personal data are processed by the University on the basis of Art. 6, para. 1, letter "c" of the GDPR the processing is necessary to comply with a legal obligation that applies to the Controller, as well as on the basis of Art. 6, para. 1, letter "e", of the GDPR Regulation, namely when exercising official powers granted to the Controller. Data on individuals with disabilities are collected on the basis of

Art. 6, para. 1, letter "a" in relation to Art. 9, para. 2, letter "a" of the GDPR - express consent of the data subject to their processing for one or more purposes.

- Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Student Graduation" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the data subjects in accordance with the requirements of the GDPR.
- **6.5.** Exchange of Bulgarian and foreign students and recognition of diplomas issued abroad The purpose of personal data processing in this operation is to organize training for ranked students/PhD students or to organize teaching for ranked professors at foreign universities at their request for a period of one or two semesters. The purpose of the processing of the foreign diploma recognition operation is recognition of the educational and qualification degree completed by the individual in the Republic of Bulgaria.

- 1. Administration of submitted Erasmus exchange applications;
- 2. Ranking of Erasmus students;
- 3. Organization and preparation for the realization of the exchange;
- 4. Reporting after completed exchange;
- 5. Administration and examination of submitted requests and documents for the recognition of a diploma issued abroad
- Personal data processed by the "Educational Activities" Department, exchange of Bulgarian and foreign students and recognition of diplomas issued abroad 1) for application under the "Erasmus" program three names; identification number; identity card data (number, date of issue, etc.); family status; citizenship; gender; permanent and current address; telephone; email; specialty; faculty number; contact person details; bank account details; 2) when performing the procedure for the recognition of a diploma issued by a foreign university, the following categories of personal data are collected and processed: three names; unified civil number or personal/identification number; date of birth; place of birth; contact address; data on completed higher education.
 - ✓ Basis for processing your personal data The data for the persons applying under the Erasmus program is processed by UNSS as a Controller on the basis of taking actions to conclude a contract at the request of the subject and execution of a contract after the successful ranking of the student art. 6, paragraph 1, letter "b" GDPR.  - Personal data processed by the Publishing Complex while accepting and processing orders for the publication of books for distance learning During the implementation of the operation, the following personal data for students are collected and processed: three names; faculty number; telephone and email.
 - ✓ **Basis for processing your personal data -** The subject's data is processed when taking preliminary actions to conclude a contract at the request of the person or to fulfill a contract Art. 6, paragraph 1, letter "b" of the GDPR.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Accepting and processing orders for the publication of distance learning books" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the subjects of the data in accordance with the requirements of the GDPR.

12. Finance Department

The Finance Department performs the following operations with personal data:

- **12.1. Administration of payments -** The purpose of the processing of personal data in this operation is the acceptance and execution of the following main categories of payments: acceptance of payments at the cash desk in the "Financial and Accounting" department; lease payments; payment of travel allowances to UNSS employees; payment for sick leave; payment for employment benefits; payment of advances; payment of fees under publishing contracts and review contracts; administration of invoices issued to and by the University; payroll processing; payment of remuneration under public procurement contracts; implementation of the approved annual budget.
 - Personal data processed by the Finance Department while administering payments names; identification number; identity card data (number, date of issue, etc.) or international passport; address; bank account details; data on health status (hospital documents).
 - ✓ Basis for processing your personal data The data on individuals processed by the "Financial and Accounting" department is collected and processed for the purposes of fulfilling a contract to which the University is a party art. 6, paragraph 1, letter "b" of the GDPR, including for the purposes of the legitimate interests of the University art. 6, paragraph 1, letter "f" from GDPR.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the "Payment Administration" operation is acceptable for performance and provides sufficient guarantees to protect

the rights and legal interests of the data subjects in accordance with the requirements of the GDPR.

12.2. Payment of scholarships, grants and awards – The purpose of the processing of personal data in this operation is the payment of social scholarships, merit and income grants, merit grants, awards or grants to the ranked persons or the persons approved to receive the announced award or grant.

- 1. Processing of the data from the submitted scholarship application;
- 2. Processing of data from additionally submitted documents;
- 3. Data processing when ranking students;
- 4. Payment of scholarships, grants and awards.
- ➤ Personal data processed by the "Finance" Department for the payment of scholarships, grants and awards When performing the operation, the following personal data is collected and processed: names; identification number; faculty number; bank account details; specialty.
 - ✓ **Basis for processing your personal data** The data on individuals, processed by the "Budget, Scholarships and Projects " department is collected and processed for the purposes of the legitimate interests of the University Art. 6, paragraph 1, b. "f" from GDPR.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the Personal Data Protection Officer considers that the operation "Payment of scholarships, grants and awards" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the data subjects in accordance with GDPR requirements.
- **12.3. Provision of accounting and tax information to state authorities** The purpose of the operation is the fulfillment of the University's obligations to provide periodic tax and insurance information to state authorities in the cases provided for by law.
 - ➤ Personal data processed by Department "Finance" at provision of accounting and tax information to state authorities When providing accounting and tax information to state authorities, the University processes the following personal data: three names of an individual; PIN if there is an invoice issued by an individual; address if there is an invoice issued by an individual for contractual relations with the University; amount of labor remuneration.
 - Basis for processing your personal data The Finance Department collects, stores and processes personal data when providing accounting and tax information to state bodies on the basis of Art. 6, para. 1, letter "c" of the GDPR the processing is necessary for the purposes of complying with a legal obligation of the Controller.
 - Conclusion of the impact assessment of the personal data operation: Based on the above impact assessment, the personal data protection officer considers that the operation "Provision of accounting and tax information to

state authorities" is acceptable for performance and provides sufficient guarantees to protect the rights and legal interests of the data subjects in compliance with GDPR requirements.
